# **Emergency Rental Assistance Program What is valid documentation?**

### 1. Live in Allegheny County

a. Determined by the online application based upon address

### 2. Below 80% AMI (At least one of the following for each adult over 18 not a full-time student)

- a. 2020 Tax Forms (do not need to be signed) must include ALL income sources for the year
  - i. 1040
  - ii. W2
  - iii. 1099
- b. Last two months of income information
  - i. Paystubs covering the last two months w/ name and pay amounts
  - ii. Pay statements covering the last two months w/ name and pay amounts
  - iii. Government documentation of benefits w/ name and pay amounts
    - 1. UC/ PUA/ SSI/ other government payment determination letter w/ effective or mailed date dated within the last 90 days
    - 2. UC/PUA/SSI/ other government payment statement of payments from last two months showing how much is paid
    - 3. Self-Certification of Income Form signed on behalf of the tenant based on their verbal statement that this income has not changed and they are unable to obtain an updated statement
  - iv. Self Certification (if top two are impossible) Form filled out and signed

# 3. Due to COVID (any one of the following for any one household member)

- a. Unemployment
  - i. UC Letter dated March 13, 2020 or later w/ name visible
  - ii. Statement in application that they had to go on unemployment due to COVID



#### b. Loss of Income

- i. Pay stub before March 13, 2020 with pay stub after March 13, 2020 showing at least a 15% loss of annual income w/ name and pay period
- ii. Third-party documentation from employer stating applicant's name w/ termination or reduction in hours due to COVID
- iii. Statement in the application that they lost income due to COVID with a brief explanation

#### c. Increase in Expenses

- i. Utility bills evidencing an increase in expenses w/ name
- ii. COVID medical bills evidencing an increase in expenses w/ name
- iii. Statement in the application that expenses increased due to COVID with a brief explanation

#### d. Financial Hardship

- i. PUA determination letter w/ name
- ii. Statement in the application that there is a financial hardship due to COVID with a brief explanation

## 4. Risk of Homelessness/ Housing Instability (any one of the following for any household member)

- a. Written lease and Self Certification form filled out and signed (lease must meet 5a criteria)
- b. Statement or notice evidencing back owed rent
- c. Statement or notice evidencing back owed utility payments
- d. Eviction notice or documentation
- e. Self-Certification of Risk of Homelessness Form signed on behalf of the tenant based on their verbal statement via phone that they owe rent or utilities

### 5. Lease (any one of the following)

- a. Written Lease w/ landlord name, tenant name, rent amount, address, and signatures
- b. Oral lease form completed and signed
- c. Utility bill, government mail w/ name and address, or photo id w/ address (if top two are impossible)
